Subject: Overloaded Chickens on Trailer (Cape Town)

Dear Colleagues,

We trust this email finds you well.

As discussed telephonically with Chief Inspector Pieterse earlier today, please refer to the attached complaint for your investigation, which at the time allegedly related to overloaded crated chickens on a trailer CAA 521991 hitched to a blue Mercedes “panel van” with registration CAA 413194 and observed by Nanandi Albers – (0723393250 / nanandi@nanandi.co.za)

The complainant was requested via WhatsApp to provide an affidavit to the Cape of Good Hope SPCA, as the SAPS is unable to assist with tracing registration numbers without a SAPS case number. She responded, “Surely its law enforcement not SAPS and he has a very well documented close relationship with the LE officers he works with”. Nevertheless, the NSPCA decided to trace the registration details as it seemed futile to obtain an affidavit from the complainant. Due to a problem with the system, the information was only received this evening, hence the delay in sending through this correspondence.
