Dear Mr Alcock

I have received and reviewed Annabella's blood test results: The only notable abnormalities are a low hemoglobin level (iron in the blood), as well as a moderate elevation in one of her liver enzymes.

Nothing points to any major underlying issues that I can pick up on her blood tests. However, the next option would be to do an abdominal scan if we want to screen for any masses in the abdomen.
