Comments: RECEIVED A CALL FROM A GUY WITH CONTACT NUMBER 061575342. I UNFORTUNATELY COULDN'T GET HIS NAME AS HE CALLED IN VERY AGGROGANTLY SAYING THAT I MUST TELL THE INSPECTOR NOT TO COME TO HIS PROPERTY TO HARRASS HIM BE A NUISANCE. HE SPOKE FOR 24 MINUTES EVEN ASKING ME FOR MY NAME AND SURNAME.
