Good evening Sipo.

It's unfortunate that I have to type this mail to you, but here we are.

I have lived in Meadow Lane for the passed 7 years. Also the property that hosts one of your community group cameras, also have you as my armed respons to my home. The big plus for myself living here is that I am an absolute wildlife and animal lover. Being so close to Somerset West central and to still have the benefit of having all the nature around me I couldn't ask for more.

I have live in this town for 38 years now, but am absolutely treated with the wildlife we have. To the point where I have started a feeding program for the prickle of porcupine's. (Prickle referring to a family or group of porcupine's.)

When I received the news of what had happened to one of our beloved animals, it made me sad, rage and sick at the same time.

I feel partly guilty for the fact of feeding and documenting these beautiful animals because of offering them food. Basically dissasociating them from fearing humans.

The damage done by your rogue responder or rather responders has left this community speechless and angry. It has scarred kids who have so much love for these animals. The fact is that, there was only one who killed the creature, but there were 3 patrol vehicles that were part of it and honestly can certainly say that they were informed by the very camera that stands tall in my property.

It was a savage hunt that has to be delt with, with the maximum penalty. I won't accept anything less, even if it costs me time and money to make sure this sort of savage act will never happen again.

You have lost my trust and safety in your company because instead of using the cameras for what they were put up for, it was used to tip off where the animal was. Then the 3 responders, patrollers that are ment to keep this community safe decided to rather illegally hunt our wildlife. These are people we are ment to trust our safety with. I trust none of it from now on.

I will be part of tomorrow's meeting in the park on Geering Street, and we as a community are going to need answers.
