3. In terms of Regulation 5 of Regulation 468, I accept that I am liable for the reasonable expenses incurred in connection with the seizure of my animal. I acknowledge that I am responsible for paying these reasonable expenses before the animal will be released to me, for such period up to and until the animal are released to me.
4. I undertake to pay to the SPCA the reasonable expenses pertaining to the seized animal, as set out in paragraph 3 above, within 7 days of the date hereof. Should I fail to settle these expenses in full within 7 days from the date of this claim, I forfeit the animal to the SPCA, for it to become the sole and beneficial owner thereof, and I consent to the SPCA disposing of the animal/s, as it deems fit, in order to recover these expenses, or part thereof (if any).
5. Neither the SPCA, nor any of its agents or employees, will be held liable for any loss or damage that I may suffer as a result of the disposal of the animal/s necessitated by my failure to settle the expenses mentioned hereinbefore, in full, within 7 days hours from the date of signing this document.

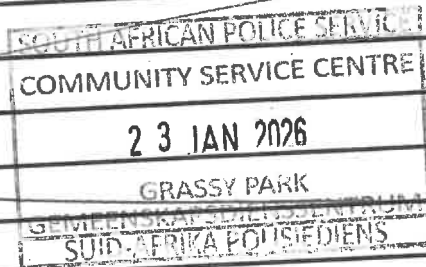
