Presenting Complaint:
Vomiting.

History:

Owner reported vomiting containing pieces of Vienna sausage, biltong, pellet-like material, and grass.

Clinical Examination:

On presentation, Gus was bright, alert, and responsive (BAR).

Vital parameters were within normal limits. No abnormalities detected on physical examination.

Assessment:

Suspected dietary indiscretion / possible toxin ingestion.

Treatment / Plan:

- Emesis induced with apomorphine.
- Vomitus consisted of partially digested/mushed food material.
- Patient hospitalised and monitored for signs of poisoning.

Hospital Course:

Gus remained BAR throughout hospitalisation. He ate voluntarily and had no further episodes of vomiting. No clinical signs of toxicity observed.

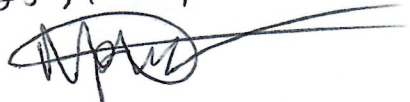
Discharge Status:
