The other 2 you had closed the case after you checked.

Good day

I reported this farmyard in Rondeberg road, off Klein Dassenberg road in July 2025 and you did check with a follow up thereafter when I phoned the case was closed.

PR 18

It is a yard with various animals from pigs to cows to goats to donkeys etc.

Nothing, but nothing has changed here in fact it has got worse with more animals, living in more filth, eating rotten food, eating food dumped alongside tons of plastic and general decay. I never see any water, the animals at times have no shelter from the heat elements.

This can no longer be considered a situation whereby the owner needs to be educated. He is hardly there, listens to no one, is hostile to everyone.

Animals are being bred for backyard sales, and probably worse, and it is atrocious with no end in sight for these poor animals. Frankly, no one on the property cares.

Can something please be done about this and please can changes be made?

I drive past there very often, and it is disgusting that animals must live like this and that the owner gets away with this time and time again.

I only have this image, but in Rondeberg road. Cannot be missed as the only filthy scrap yard in the road and your inspectors have been there a few times already.

My case numbers last year. Your case reference number is INSP220699/ 220700/ 220701

So originally, I reported 3 cases in Rondeberg Road as referenced above.

I'm not sure which number above is related to my below repeat request on PR18.

PR 1 CASE CLOSED

PR 22 CASE CLOSED

PR 18 - the case was closed after your follow up at the scrap yard, but this is ongoing and getting worse. It needs to be dealt with please as people are concerned to the goings on in that property aside from the lack of care to the animals, but as I mention, now again, it is hostile so please come prepared for push back from people in the property, who have clearly changed nothing since your last visit, and has only got worse. The animals live in squalor and it's shameful that this continues. From time-to-time people take teff or oat hay to help the animals, but that just makes it easier for the owner not to provide or comply.
