This documentation can be provided if required. All the cats are in excellent health and are well cared for. These cats are my family and are dearly loved. We have lived in our home, which we own, since 2014 and this is the only home they have ever known. We have a 2 income household which provides more than adequately for their care. Food, cat litter and medical expenses ,if required, are provided for by us. They pose no nuisance to anyone. Their surroundings are clean and hygienic with no odour from waste as their litter boxes and spaces outside are cleaned twice daily. There have been exaggerated complaints made to no avail. This has now made us aware of the requirements for a permit. We have co-operated with the inspectors with no findings of animal neglect. Everything has always been found to be in order.

We are willing to comply with any reasonable requests attached to this permit .
