INCIDENT DETAILS

- Date: Thursday, 30 July 2026
- Time: Approximately 17:00
- Place: No. 27 Rail Road, Forrest Resort, Monte Vista, Goodwood
- Weather: Sunny
- Lighting: Daylight with good visibility

On Thursday, 30 July 2026, at approximately 17:00, I went to No. 27 Rail Road, Forrest Resort, Monte Vista, Goodwood, where Wesley Roberts resides, in order to collect my cellular telephone from Amy. My dog, Molly, accompanied me.

After Amy handed me my cellular telephone, she walked me to the entrance gate and closed it behind us. As the gate was being closed, Wesley Roberts' dog, Haley, suddenly ran out of the property and attacked Molly. The attack occurred outside Wesley's yard, approximately two metres from the entrance gate.

This has been an ongoing problem as Haley has previously fought with my dogs.

I immediately shouted for help. My other dogs, namely Shawnee, Jessie and Bully, heard me shouting and ran towards me. Amy and I attempted to separate Haley and Molly.

While we were attempting to separate the dogs, Wesley Roberts came outside and observed what

I, the undersigned, Sandy Arendorff, hereby state further under oath:

was happening. At no stage did he attempt to separate the dogs or restrain his own dog, Haley. Instead, Wesley turned around, went back inside his residence and shortly afterwards returned carrying a green spade with a wooden handle and a flat metal blade.

Without saying anything, Wesley immediately started striking my dogs with the spade. I personally observed him strike Shawnee, Molly, Jessie and Bully approximately two to three times each. I specifically observed Wesley strike Jessie over the head with the spade.

As Wesley continued striking my dogs, they attempted to run away from him. Despite them trying to flee, Wesley continued striking them. At no stage did I observe Wesley strike, remove or restrain his own dog, Haley.

My boyfriend, Tako Swanepoel, together with Wesley's cousin, Chad, and other persons who were present, assisted in separating the dogs and eventually brought the incident under control.

After the dogs had been separated, all of my dogs ran back towards my residence.

A short while later I was informed to look at Jessie. I found Jessie lying outside my residence. Jessie was no longer breathing and appeared to have died shortly after the incident. I also noticed that Jessie's eyes appeared completely black. Jessie had no visible external injuries.

I believe Wesley Roberts unlawfully assaulted my dogs by repeatedly striking them with a spade, resulting in the death of Jessie and injuries to Molly and Shawnee.

I respectfully request that the South African Police Service investigate this matter.
I have no reason to lay a false charge or falsely implicate any person.
I am prepared to testify in court to the contents of this statement.

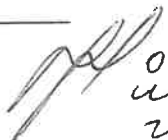
