3. THE ANIMAL CANNOT BE PASSED ON TO A NEW OWNER. THE ORIGINAL STERILIZATION CONTRACT WILL BE CANCELLED AND A NEW ONE ISSUED IN THE NEW OWNER'S NAME FREE OF CHARGE.
