Report/Findings: Upon inspection the greyhounds were confined in a small, inadequate enclosure that restricted their movement. The dogs were sleeping directly on the floor without bedding which raised concerns in welfare of animals. One greyhound was observed limping on front right leg which was from a previous fracture that didn't heal properly. The dog appeared to be in discomfort and no previous vet report was provided.
